Mr. James Sung Fu Tong, currently a Director and the former Chief Executive Officer of the Company, has accepted the role of Interim Chief Executive Officer. Mr.

Tong has been instrumental in Muzhu's execution of the option agreement to acquire up to 80 per cent of the advanced XWG silver/zinc/lead property in the city of Luoyang, Henan province of China.

The Company also continued reviewing various exploration options for its Sleeping Giant South project (15,000 acres), located in Quebec's Abitibi greenstone belt and contiguous to the south of the Sleeping Giant mine held by Abcourt Mines.
