The Issuer focused its initial sales efforts towards the B2B wholesale market in Canada and had its flower sold in nine provinces by several wholesale partners over the past two years. The Issuer is in progress of diversifying its sales channels further which can be expected to commence in the coming quarters while currently having cannabis flower sold in BC and Ontario in partnership with Kolab Project Inc.
